



FOOD BOOTH VENDORS

27th ANNUAL WALDO FALL FESTIVAL

SATURDAY, SEPTEMBER 21, 2019 | 10:00 A.M. – 5:00 P.M.

ENTRY FEE: \$150 for Waldo Members and \$200 for Non-Members. Food vendors must provide booth, generator and must be registered with the City of Kansas City and maintain all required permits.

VENDOR BENEFITS: All vendors will have the opportunity to sell food and non-alcoholic beverages to the Waldo Fall Festival attendees. Additionally, each vendor will receive pre-promotional support through the Waldo Area Business Association’s social media channels.

TYPE OF FOOD: The type of food must be stated on the application and approved by the Festival Committee.

SET-UP: The festival will be held in the parking lot at the southeast corner of 75th and Wornall. Set-up time is 7:00 a.m. – 9:30 a.m. on Saturday, September 21. The Waldo Fall Festival Committee will provide arrival time slots for each vendor prior to the day of the event.

CLOSING TIME: Participants are asked to stay until the conclusion of the festival at 5:00 p.m. Vendors are responsible for cleaning all debris from their area before leaving.

CANCELLATION: If any reason whatsoever makes it impossible to have the event, the contract shall terminate and WABA shall not be liable for any claim for damages, except the return of the entry fee. Booth fees will be refundable up until confirmation date with a written request from exhibitor. If for any reason you are not accepted into the festival, your fee will be refunded. If you cancel after August 16, 2019, only one-half of the fee will be refunded.

CONFIRMATION: The application deadline is September 3, 2019. Confirmation will be sent within two weeks of application receipt. Applications received on September 3 will be notified of confirmation by September 9, 2019.

INDEMNITY: The vendor cannot hold the Waldo Area Business Association, Waldo merchants, directors, agents or employees for any and all expenses, claims, actions, liabilities, damages and loss connected with operation of said booth. Any damages or loss of personal property or merchandise is the responsibility of each exhibitor.
